Summary of points raised.

- There were questions raised about the lack of attendance of representatives from the project team.
- Concerns were raised about the consultation process being 'misleading' as certain representatives were not present.
- Suggestions were made to re-write the website to address 'misleading' claims of consultation members.
- Residents expressed frustration due to lack of knowledge about the development.
- Residents expressed significant worry over the costs involved.

- Greater clarity requested by residents over the distribution of costs and how much leaseholders can expect to be charged.
- Greater clarity requested by residents over the final designs and what this entails.
- More information requested by the residents for the plan in allocating the costs.
- An argument was raised by a resident that leaseholders should not be billed for the window replacements, rather it should be the council.
- Questions raised over legality surrounding the distribution of costs.
- Request for more frequent correspondence and updates to be delivered to residents.
- Suggestion made to do a walkabout around the estate at the next meeting to gain a greater understanding of the development.
- Requests were made for more legal advice surrounding costs of repairs to be made available to residents.
- Concerns were raised about the value of people's homes decreasing due to uncertainty surrounding potential costs of windows. This, in turn, has made it harder for people to sell.
- Suggestion made by residents that all councillors involved should be present at each meeting.
- Residents expressed frustration at lack of ventilation in their bathrooms.
- Complaints were made about mould problems and low flow of air in ventilation systems.
- Each home will have different ventilation needs.

Next meeting will be from 6.00 pm – 7.00 pm on Thursday 26 October 2023 in the Lower Floor space of the Golden Lane Estate Community Centre.
