

#### **PROJECT NEWSLETTER - AUGUST 2024**

Welcome to our project newsletter about the works taking place at the former library site in Horley. Construction works have commenced to deliver two town houses and six apartments as part of Surrey County Councils "Right Homes, Right Support Programme".

We will continue to publish regular newsletters throughout the project to provide progress updates and also inform you of movements in and around the construction site.

#### What's the project about?

This Supported Independent Living scheme has been designed to allow working age adults with a learning disability and/or autism to maintain or develop their independence and be part of the community. The overall aim of the scheme is to provide sensitive, specialist residential accommodation, which is much needed in the local area.

Currently, there are limited options for suitable accommodation in Surrey. This means that a significant percentage of working age adults supported by Surrey County Council's Adult Social Care (ASC) team are placed out of county. These individuals are therefore distanced from their family and their social care professionals (Social Workers). Enabling people to return to and live in Surrey would reduce the need for their families and Surrey

County Council professionals to travel as far (often in a car) to maintain personal contact.

#### **The Former Horley Library Site**

The former Horley Library site covers approximately 0.32 hectares and is located within Horley town centre.

Following completion of the new library on Russell Square, this site was selected for the Horley Supported Independent Living scheme.

The design focuses on ensuring residents and their care workers will have sufficient space, and key to this has been the design considerations around the accessibility needs of the residents. The accommodation has been configured to ensure residents can remain in their own home as they age and/or their needs change. All the accommodation has been designed, in consultation with occupational therapists, to be wheelchair accessible and adaptable, meeting M4(2) standard internally and externally. Two of the six self-contained apartments and one bedroom in each of the townhouses have been designed to the higher M4(3) standard so they will be ready for current, potential and future wheelchair users.
